

# PATRICIA GARWOOD National President 1985-1986

Patricia L Garwood left this world at about 11:30 pm, March 7, 2019, in the presence of her son Richard, who held her hand as they said a prayer, and Pat drifted off in peace. Pat served the Auxiliary as National President 1985-86 and presided over the 54th national convention in Boston at the Marriott Copley Place which was so appropriate as she was from the New England area. She ended her year with 23,547 members and that was a loss of 401 members (but of that 401 - 313 were deceased). Her NP project that year was the beautiful Homecoming Bas Relief at the Navy Memorial, Washington, DC (unfortunately for her not enough donations were received so NP Sweeney and NP Pounds continued her dream). The C&BL's and Standing Rules were completely updated by PNP Gail Johnson her By-law chairman. Doreen Huylebroeck was proud to be elected as NES during Pat's convention. A few years later 1990-1991 Pat served as Parliamentarian for NP Doreen. Pat attended her last National Convention in 2017 in Hunt Valley MD, where she was greeted with open arms by many LA FRA and FRA members. She renewed old friendships and made a few new ones. Pat was loved and admired by all who knew her.

Pat joined the LA FRA April 1, 1967 and was currently a member Unit 91.

Pat will be laid to rest, at a future date, at Arlington Cemetery, where she will be reunited with her husband Jim. She will be greeted there by our very own Arlington Lady PNP Doreen Huylebroeck who will accompany Pat on her final journey.

Please keep her son Richard Garwood and other family members in your prayers as they make this sad journey.
