She immediately went down 4 there to be with her. Her son flew from Kansas to be 5 down there with her. They had to do all the things 6 because it was an unattended death, it was a crime 7 scene. So they had to -- she had to stay in 8 Jacksonville and wait for them to do investigation to 9 show that it was not. Anyway, we got back -- everybody 10 got back to Kansas. The next day I got a phone call. 11 My niece in Kentucky who is a double amputee -- and I 12 had just gotten back from spending the week out there 13 watching her -- unresponsive. And praying as hard as we 14 could, but she passed away the day after my son-in-law 15 passed away. So I was unable to go to Kentucky for 16 obvious reasons for her funeral. Needless to say, 17 Thanksgiving 2017 was a bust. 18 I have four grandsons, one granddaughter, two 19 daughters, and a grown son retired from the Air Force 20 who all belong to the LAFRA. And, no, I do not pay all 21 of their dues. My daughter Debbie Davenport -- or her 22 name was Fri at the time, is a Charter member of Unit 23 40. She had just turned 16 when I was organizing the 24 Unit, so she ended up being a Charter member and she's 25 pretty much had continuous membership.</p>
