As I have journeyed through this year, it has come to my attention that we may be overusing the FRA, LA FRA emblem. Copyright laws let creators control their works. By assigning exclusive rights to copyright holders, the laws ensure that only the originators and those who receive their permission can copy, perform or change the works. American copyright law came about to benefit the public from the original works of authors.

Under the doctrine of "fair use", individuals may be permitted to make backup copies or archival copies of some materials if certain conditions are met. Creating a copy (or using the LA FRA emblem) of a copyrighted work (which is what the Triangle emblem is) for your own ease of use is likely to be considered copyright infringement. Please remember this when you are using the FRA or LA FRA Triangle Emblem on whatever item you wish.

There must be written permission to use the Triangle Emblem as that is an emblem that has been copyrighted just for the FRA and the LA FRA, please be aware that you can't just stamp this on any item. The Triangle emblem is for official business and to use the emblem, you will need to get permission from the National Board. There are legal penalties for using a copyright without permission. Please keep this in mind.

If you have not yet donated to my NP Project, we will be accepting monies if you wish to give. Good luck to the winner of the jewelry, whoever that may be. The jewelry will be given away at the National Convention Banquet on Saturday night.

## **DID YOU KNOW?**

THE LADIES AUXILIARY OF THE FLEET RESERVE ASSOCIATION IS COMPOSED OF SPOUSES, PARENTS, GRANDPARENTS, SISTERS, BROTHERS, CHILDREN, STEPCHILDREN, AND GRANDCHILDREN NOT LESS THAN SIXTEEN YEARS OF AGE, OF MEMBERS OF THE FLEET RESERVE ASSOCIATION: AND WIDOWS, WIDOWERS, PARENTS, GRANDPARENTS, SISTERS, BROTHERS, CHILDREN, STEPCHILDREN, AND GRANDCHILDREN NOT LESS THAN SIXTEEN YEARS OF AGE, OF PERSONS WHO WERE MEMBERS OF THE FLEET RESERVE ASSOCIATION OR ELIGIBLE FOR MEMBERSHIP AT THE TIME OF THEIR DEATH. IT HAS CERTAIN AIMS AND PRINCIPLES WHICH DISTINGUISH IT FROM OTHER PATRIOTIC ORGANIZATIONS.

"The first principle of the Ladies Auxiliary is Loyalty. You must be loyal to your Flag and your Country, to the community in which you live and to members in this Auxiliary. Let no word or deed of yours cause any injury to the person or family of any shipmate."

"The second principle of our Auxiliary is Protection. As a member, you have certain rights and privileges. It has been the experience of many that only by constant vigilance can we protect our rights. It is evident, then, that United we stand and United in organization there is strength. For this reason, we have banded together in an Auxiliary for mutual protection."

"Service is the third principle of our Auxiliary. It is not only the aim of this Auxiliary to render service to its members and their families, but also to the United States Navy, Marine Corps, and Coast Guard. If a member is sick or is in distress, render what service you can, and then notify the officers of your Auxiliary. It is our duty to assist in good fortune or distress."

"The Symbolic Triangle is the symbol of the Ladies Auxiliary of the Fleet Reserve Association. From the United States Flag to the Unit Banner signifies Loyalty; the Unit Banner to the Altar represents Service; and from the Altar to the United States Flag represents Protection. (We do not break this invisible line). The area within the Symbolic Triangle is reserved for the performance of Ritual ceremonies. The Triangle is the emblem used officially, when appropriate, which indicates the three Sea Services the United States Navy, Marine Corps and Coast Guard."
