Proposed by National Board Duties of the National Financial Secretary as it pertains to membership

Resolution to Change Section 809(q). Currently states "The official Unit voting strength and list of Unit groupings for competitive awards is the responsibility of the National Financial Secretary who notifies the National Executive Secretary, Units and Regional Presidents by 15 May".

Whereas if there is a positive vote to combine the duties of the Membership Service Administrator and the National Financial Secretary and

Whereas The new duties as it pertains to membership need to be added to the National Financial Secretaries duties in the C&BL's and

Whereas 809(q) seems to be the logical place to add these duties and

Whereas the combining of these two offices have been reviewed by the LAFRA and FRA National Parliamentarians and is in the best interest of the LAFRA therefore be it

Resolved section 809 (q) be changed to read "Duties of the NFS as it pertains to Membership"

809(q)(1) The NFS shall process and maintain the LA FRA membership records.

809(q) (2) The NFS shall generate membership renewal billings.

809(q) (3) The NFS shall send membership cards for new members, members paying dues, members transferring to another Unit, and replacement cards.

809(q) (4) The NFS shall update records, address changes, dues payments, terminations, etc.

809(q) (5) The NFS shall send second billing notices at 60 days past due.

809(q) (6) The NFS Receives dues payments, accounts for all dues received and deposit dues monies into the PCT account providing the National Treasurer with a monthly report by Unit.

809(q) (7) The NFS shall provide the following additional reports as they pertain to membership

(a) Report all transactions processed during the month by Unit, subdivided by payments, additions, deletions changes, monthly statistical information to each Unit

(b) Provide a Report to each Unit monthly which includes, members whose dues expire the following month, members whose dues are in arrears 30, 60, 90 days and any reported changes to addresses, phone numbers, emails all members terminated for nonpayment, ineligibility, or resignation.

(c) Report of alpha listing to each Unit including MAL report to NVP & NES, monthly. Complete Alpha listing to NP, NVP, NES, and NT, monthly.

(d) Maintain Life Membership listing until such time as all life members are verified deceased, report to NP and NVP status, annually.

(e) Report to each Regional President and Regional Vice President, for each Unit of the Region, changes, past due members, and Unit status report, monthly. Each Regional report also sent to NP and NVP, monthly.


(f) Report annual stats to include percentage of gain or loss for Unit membership, from 1 April to 31 March, to NP, NVP, Regional President(s), and Regional Vice President(s) and to each Unit, annually. Due to Units by 15 May.

(g) Report of deceased members for 1 July thru 30 June. This report will be listed by Region, then Unit, then alphabetical by last name. This will be sent to the NP, NC and NES monthly, and Each Regional President, annually to be received by 10 July.


(h) Maintain report of all new and reinstated members to include the member who recruited them report dates 1 April to 30 March. Provide to NP and NVP by 30 April.

(i) The NFS confers with the NT and NES regarding all Units which have not complied with Article 14, Section 1404, and 1405(e) by 15 July. The NFS shall notate the receipt of Unit PCT funds to be placed in a hold status until such time as the Unit complies.

Resolution to abolish the Office of Membership Service Administrator and assign the Duties to the National Financial Secretary
Proposed by National Board

SR-18. Membership Service Administrator

SR-18(a) The LA FRA NBOD, shall select a Membership Service Administrator for the purpose of maintaining the LA FRA membership records. The period of the agreement shall be stipulated in the agreement. The total obligation to the LA FRA for the Membership Service Administrator shall be in accordance with the budgeted line item approved by the delegates at the National Convention. The Membership Service Administrator shall receive a working fund at the beginning of the agreement also in accordance with the budgeted line item approved by the delegates at the National Convention. This working fund shall be returned at the conclusion of the agreement.

WHEREAS the membership of the LA FRA is currently less than 6000 members and

WHEREAS the daily duties of the Membership Service Administrator continues to decrease and


WHEREAS the duties of the MSA and NFS overlap on several reporting requirements to the Units and


WHEREAS the costs of maintaining two separate offices is no longer cost effective and

Whereas, A Unit would need to select a reputable business to digitize the LA FRA Logo, and



Whereas, The NBOD shall keep in mind how the Logo is going to be used and who is digitizing it; now, therefore be it

Resolved, That Article 8 Section 802 (k) is added stating The NBOD may grant permission for use of the LA FRA Logo to a Unit. The Unit must petition the NBOD with details on the use of the Logo. The use of the logo should be granted for a specific item and/or timeframe.

Resolution: Article 13 Section 1312 (a)

Whereas, Article 13 Section 1312(a) states "A Branch shall have the authority to interpret and apply the law in matters pertaining to its Auxiliary. The Unit shall submit its bylaws and amendments thereto to the Branch Board of Directors for ratification."; and

Whereas, the statement is vague and needs to be clarified as to what law a Branch is to have jurisdiction over to interpret and apply; and

Whereas, the guidelines for the operation of a Branch is the FRA C&BL and Standing Rules, and

Whereas, LA FRA C&BL Article 11 Section 1101(a) and Article 14 Section 1401(b) states that no Unit of the LA FRA shall be organized until the Branch, whose name and number the Unit will bear, has complied with provisions of Section 1309, C&BL of the FRA; and

Whereas, a Branch is governed by the C&BL FRA; and


Whereas, when a Branch authorizes the establishment of an Auxiliary, it states it is to be governed under the guidelines of the FRA C&BL; and

Whereas, an Auxiliary shall establish Bylaws and Standing Rules to govern its operation: and

Whereas, in Article 13 Section 1314 (FRA/LA FRA) states that: Whenever the Constitution and Bylaws and Standing Rules of the Auxiliary may be in conflict with the C&BL FRA, the provisions of the latter shall prevail; and therefore be it

Resolved, that Article 13 Section 1312(a) A Branch shall have the authority to interpret and apply the Bylaws (C&BL FRA) in matters pertaining to its Auxiliary. The Unit shall submit its bylaws and amendments thereto to the Branch Board of Directors for ratification.

Whereas, Article 14 Section 1412 Compliance states: Units comply with the laws and ordinances of the country, state, county and city in which the Unit is located; and


Whereas, it is vague in context and needs to be more specific on IRS regulations for nonprofit Veterans Organizations; and

Whereas, In accordance with Federal IRS regulations on nonprofit Veterans organizations, each Unit is required to have their own EIN number registered in their name; and

Whereas, annually the Unit must file a 990-N with the IRS to maintain their tax exempt status; and ; now , therefore be it

Resolved, Article 14 Section 1412 become Article 14 Section 1412 (a) Compliance - Units comply with the laws and ordinances of the country, state, county and city in which the Unit is located; and Article 14 Section 1412 (b) be added, Each Unit must obtain an EIN number registered in their name. Once an EIN number has been obtained a Unit must file a 990N annually with the IRS. A copy of the Receipt of Confirmation for the filing must be retained in the Unit's file and be sent to the National Treasurer for the National organizations files.
