Members of the Ladies Auxiliary, I am the National Department of Veterans Affairs (VA) Voluntary Service (VAVS) Representative for 2019-2020. The Auxiliary is looking for volunteers to be VAVS Representatives. Presently we are a honorary member with twelve (12) VA facilities represented but the VA's requirements are a minimum of twenty five (25) volunteers before an organization would be considered a member of the National Advisory Committee.

The duty of the VAVS Representative or Deputy Representative is to be the liaison between the LA FRA unit(s) in their area and the VA facilities such as a VA Medical center, independent outpatient clinics, or the Fisher House. There is a requirement that a representative or a deputy representative attends at least 3 consecutive quarterly meetings of the VAVS National Advisory Committee or the LA FRA's membership can be terminated. At the meetings you will be informed of what the facilities need for the Veterans such as gift cards, gas cards, bus passes, and clothes. You don't have to be a volunteer at a facility to be a representative but any member can be a volunteer. There is always a need for volunteers, you may assist Veterans by augmenting VA Staff in such settings as hospital wards, nursing homes, ambulatory care, domiciliary, community-based volunteer programs, end of life care programs, veterans outreach centers, national cemeteries and limited assistance in veterans' home.

If any of these facilities are near you and feel volunteering would be possible, please consider becoming a volunteer and or a representative-deputy representative.

#### Tips to a complete package:

- #1 Fill out all information and do not leave anything blank, write N/A if a section does not apply to you.
- #2 Make sure to enclose the essay, community service, scholastic activities as each are required.
- #3 Make sure to include transcripts and the letters of recommendation. Consider providing your teacher or community leader with a self-addressed envelope with a date in the corner prior to 15 March and have them sign across the seal and return to you.
- #4 Remember to request your high school and or college transcripts early.
- #5 Enclose all required documentation using the check sheet provided and send a completed package.
- #6 Most important make sure to mail in time to be received by the deadline of 15 April 2020: Mail to FRA Education Foundation, ATTN: LA FRA Scholarship, 125 N. West ST, Alexandria, VA 22314-2754.

#### February Dates to Remember:



April 25, 2020 – LA FRA Pilgrimage to the Mast of the Maine and the Tomb of the Unknown. Old (and very small) photograph of the USS Maine in an unknown yard in Havana Cuba – 1898(?).



The USS Maine Mast Memorial is a memorial honoring those who died aboard the USS Maine (ACR-1) after a massive explosion of [then] unknown origin destroyed the ship while at anchor in Havana Harbor. An official U.S. Naval Court of Inquiry ruled in March that the ship was blown up by a mine. In 1976, a team of American naval investigators concluded that the Maine explosion was caused by a fire that ignited its ammunition stocks, not by a Spanish mine or act of sabotage. https://www.history.com/this-day-in-history/the-maine-explodes





The blackened canteen is a recovered relic from a B-29 bomber that collided with another B-29 over the city of Shizuoka, Japan in 1945. Twenty-three American airmen were killed. The American dead were buried among the Japanese citizens of Shizuoka who were killed during the bombing raid.
