

Article 14 - Unit Organization

Section 1405. Nominations and Elections of Unit Officers

Section 1405(a). Nominations for Unit Officers shall be opened at a meeting in March, April, or May, as specified by the Bylaws of each Unit. They remain open until a meeting in the month following opening of nominations, then closed, and officers elected for a period of one year, except that Secretaries and Treasurers may be elected for a period of two years.

Section 1405(b). *Units outside the continental limits of the United States may if they desire, nominate, elect, and install Unit Officers in three consecutive months*, as specifically provided for in the Bylaws of the Unit. However, the process for the nomination and election of Unit Officers shall be carried out in the manner prescribed in Section 1404.

Unit Officers installation in month following election.

Unit Secretaries need to submit the Unit Officer Information form (The form is available on the LA FRA website la-fra.org) after elections but before installation of officers. On the main page, left hand side, click on the tab - LA FRA Forms, on the form page click on the 4th form in the right hand column to have the form downloaded.

The Office for the National Treasurer will become vacant this administrative year. Units may submit Resolutions per C&BL Article 6 Section 608 to nominate candidates for the position to be considered at the National Convention. Resolutions are due 120 days before the Convention and may be submitted to the National Executive Secretary. The duties are as outlined in the Constitution and Bylaws.

Duties of the National Treasurer C&BL Article 8 Section 810

Section 810(a). The National Treasurer is responsible for the accurate and proper maintenance of the financial records of the LA FRA. An accurate and true record of all receipts and disbursements shall be recorded and no change shall be made without the approval of the NBOD. Supply the NBOD, and the Audit Committee and Budget and Finance Committee with information as may be requested and allow any authorized committee or authorized member to examine or audit the books and accounts at any time.

Section 810(b). Upon receipt of properly drawn voucher, the National Treasurer will issue a check. The signatures of the National Treasurer and the National President will be on all or may be affixed by a signature stamp. If the bill is irregular or in some manner out of order, the Treasurer has the authority to refer the matter to the NBOD via the National President for decision.

Section 810(c). The National Treasurer submits quarterly reports, which have been audited, to the NBOD and to all Units showing receipts and disbursements, and issues any other reports as directed by the NBOD. The National Treasurer prepares and makes an Annual Report to the NBOD and to the National Convention, showing gross receipts, expenditures, and balances on hand at the end of the fiscal year, together with recommendations. Recommendations requiring action of the National Convention shall be in official format with copies for the delegates.

Section 810(d). The National Treasurer prepares an inventory of all tangible properties of the LA FRA with the following information: name of equipment, location of equipment and whose inventory; price when purchased; present estimated value; and all other information pertinent to the subject. The inventory is to be submitted to the NBOD Pre-Convention meeting.

Section 810(e). No, LA FRA properties of any value shall be surveyed, sold, or destroyed, without prior approval of the NBOD.

Resolution to Amend Section 604(d)

Proposed by Chesapeake Unit 40

Section 604(d) Minutes of the convention shall be recorded with no omissions, deletions, or alterations, except as directed by the delegates assembled at the convention. The Jr. Past National President has the authority to use discretion to use a new format in publishing the National Convention Minutes.

WHEREAS: the Internal Revenue Service Manual 1 itself provides the following instruction to examining agents: The minute book of an exempt organization usually provides a summary of the activities conducted during the year. and

WHEREAS the IRS exempt organization guidelines further states In recording the minutes of a director's meeting, the secretary, though under an obligation to keep the minutes faithfully, is not obligated to include everything that is said in the minutes as long as the minutes accurately transcribes what has taken place. and

WHEREAS Citing Robert's Rules of Order, the Court further stated: "Generally, the minutes should contain mainly a record of what was done at the meeting, not what was said by the members. Their purpose is to reflect matters such as motions made, the movant, points of order, and appeals — not to show discussion or absence of action." and therefore be it

RESOLVED that section 604(d) state Minutes of the convention shall be presented in a **summarized** format. The Jr. Past National President has the authority to use discretion regarding the documents type set and page layout when publishing the National Convention Minutes.
