LA FRA Eligibility Requiremento

Article 13, Section 1305. Membership Eligibility - Membership eligibility shall be determined by the LA FRA in compliance with Internal Revenue Service regulations governing membership in the auxiliary of veteran's organizations.

Article 3, Section 301. Eligibility for membership in the LA FRA shall be restricted to the following personnel.

Article 3, Section 301(a). Membership in the LA FRA shall be limited to spouses, parents, grandparents, sisters, brothers, children, stepchildren, and grandchildren not less than sixteen years of age of members of the FRA and widows, widowers, parents, grandparents, sisters, brothers, children, stepchildren, and grandchildren not less than sixteen years of age of persons who were members at the time of death or eligible to be members of the FRA at the time of their death after:

1924- USN, USMC enlisted male personnel that transferred to the Fleet Reserve. (Retired from service after 1924).

1970 – Career designated Enlisted USCG, USN, USMC, and USCG female service members.

1975 - All Active Duty Sea Service Personnel USN, USMC, USCG from the first day of enlistment.

- a. If an officer had one day of credible enlisted service, they are eligible for FRA membership and their family members are eligible for LA FRA.
- b. It applies to active-duty service members who are alive today and currently serving on active duty, or the potential sponsor who died on active duty after 2005. (this would also apply to those who died on active duty without enough time to receive a DD214, less than 180 days of service the family member will only have a DD1300 and death certificate)

2005 – All Former Enlisted USN, USMC, and USCG service members who were not discharged under a Bad Conduct Discharge or Dishonorable Discharged as prescribed on the DD214. (An enlisted service member with a bad conduct discharge or dishonorable discharge is not eligible for membership in the FRA. Therefore, their family member is not eligible for membership in the LA FRA).

If the sponsor is still alive, they MUST be current members of the Fleet Reserve Association. If the sponsor is deceased, you MUST verify the eligibility as prescribed in the above dates using the sponsor's DD214. (The unit cannot retain the DD214). Applications must be signed by the responsible person in the Unit, signifying the applicant and the sponsor have been properly vetted. The NFS will return all application forms that do not meet all the above criteria.

In the following examples, the use of the word CHILDREN is inclusive of any stepchildren/step-grandchildren. However, the Stepparents (of potential sponsors) who did not adopt the sponsoring sea service member are not eligible for LA FRA membership.

If an FRA member lets their dues lapse and is no longer a member in good standing, the family members ARE NOT eligible for membership in the LA FRA. If the family member is a current member of the LA FRA, they will be deemed ineligible.

Article 3, Section 301(b). Any member of the LA FRA may be required to prove their eligibility for membership at any time. In case a member's right of membership is challenged and is found to be ineligible as described in Article 3, Section 301(a) their name shall be removed from the membership roll, without prejudice, and the last payment of dues shall be prorated and refunded, less administrative cost.

Example #1: If the POTENTIAL SPONSOR is currently a member of the FRA in good standing, his spouse, children & grandchildren over age 16, siblings over age 16, and parents and grandparents are eligible to be members of the LA FRA.

Example #2: If the POTENTIAL SPONSOR was a member in good standing at the time of death, the widow or widower, children & grandchildren over age 16, parents, and grandparents are eligible to be members of the LA FRA.

The FRA member's name as the sponsor and the FRA membership number should be provided on the LA FRA application. The FRA branch should work with the Unit to verify members in good standing.

Example #3: If a current active-duty enlisted member of the sea services becomes a member of the FRA at a recruiting open house, therefore, their spouse, children & grandchildren over age 16, siblings over age 16, and parents and grandparents are eligible to be members of the LA FRA.

(They will not have a DD214 however the service member will have a DOD ID card that states Active Duty). The spouse and children over age 10 will also have a DOD ID with Active Duty and relationship.

If the active duty member does not join the FRA, the family members are not eligible to be members of the LA FRA.

Example #4: A veteran of the SEA SERVICES becomes a member of the FRA at a recruiting open house, therefore, their spouse, children & grandchildren & siblings over age 16, parents, and grandparents are eligible to be members of the LA FRA. If the veteran does not join the FRA, the family members are not eligible to be members of the LA FRA.

(They may not have a DOD ID card therefore a DD214 is required to verify the eligibility).

Example #5: A widow of an enlisted male Navy or Marine who served over 20 years and retired from the Navy or Marine Corps after 1924 would be eligible for membership along with the children & grandchildren over age 16, siblings over age 16, and grandparents and parents of the service member as the service member was eligible to be a member of the FRA at the time of death. A DD214 is required to be shown to verify eligibility. This would also apply to the widows and eligible family members of Officers who had one day of creditable enlisted service who retired as an officer after 1975.

Example #6: A Coast Guard service member or a female Marine, Sailor, or Guardsman who was career designated (retired after 1970). Their spouse, widow, children & grandchildren over age 16, siblings over age 16, & grandparents and parents of the service member are eligible to be a member of the LA FRA. A DD214 is required to be shown.

Example #7: Any Sea Services enlisted service member who died after 2005 and had received a DD214, their widow, children & grandchildren over age 16, siblings over age 16, and grandparents and parents of the service member are eligible for membership as the veteran was eligible to be a member of the FRA at the time of death. A DD214 is required to be shown.

Example #8: A grandchild of a service member who only served 36 months of enlisted time in the Navy during the time of the Korean War and died in 2002 would not be eligible for membership in the LA FRA as the service member did not meet eligibility requirements at the time of their death. They were neither retired from enlisted service nor a current member at the time of death.

Example #9: A female enlisted Navy service member who served 3 years in the 1960s and subsequently died, her family members would not be eligible, as women were not eligible to be members of the FRA until 1970 and they had to be retired from the service to be eligible.
